PRODUCT DESCRIPTION

Increte Systems HIGH GLOSS WAX is a clear, durable wax that resists surface abuse when properly maintained and leaves a beautiful high gloss finish. Heel mark, stain, and abrasion resistant, **Increte Systems HIGH GLOSS WAX** is easily buffable and free from odors and fumes during application.

APPLICATION PROCESS

HIGH GLOSS WAX can be used on sealed Increte Stamped Concrete, Stain-Crete, sealed concrete floors & slabs, terrazzo brick, Mexican tile, Ceramic Tile, Slate, Adobe, and Quarry Tile as well as parquet and sealed wood.

Coverage – Approximately 1,500 to 2,000 square ft. per gallon (3.785 L), depending on type and texture of surface and method of application.

Procedure – Sweep and mop floor. Remove old wax (if present). Let dry and apply HIGH GLOSS WAX with mop, sponge, cloth, or by mechanical means.

Apply second coat in heavy traffic areas or where needed. Allow 30 minutes intervals between coats. Repeated coats will produce a very durable, high gloss finish. HIGH GLOSS WAX can be removed using Increte Systems' GREASE-A-WAY, degreaser/wax stripper.
